- Identify appropriate release sites and assist with managing animal releases.
- Maintain rehabilitation records and prepare statistics and reports.
- Manage, train, and supervise volunteers and summer staff.
- Maintain a positive, healthy, and safe work environment.
- Assist with inventory and ordering of supplies and equipment.
- Housekeeping duties including laundry, dishes, floor cleaning, etc.
- Assist with public relations via press, published articles, etc.
- Ensure the proper maintenance of facility, equipment, and caging.

- Undergraduate degree in a related field (e.g.: biology, zoology) and/or Animal Health Technologist diploma.
- At least one (1) year of experience in a wildlife rehabilitation centre or veterinary clinic.
- Excellent project management and time management skills, and the ability to perform well under pressure.
- Great verbal and written skills.
- Completion of IWRC's Basic Wildlife Rehabilitation 1AB course would be an asset.
- Rabies vaccination would be an asset.
- Knowledge of Alberta wildlife and natural history.
- Ability to take initiative and to work independently and within a team.
